



ACRYLIT 10 LIMITED YEAR WARRANTY

Under the terms stated below, Glasteel / Stabilite America, Inc guarantees for 10 years from the date of invoice light transmission through its frosted, fiberglass reinforced, plastic sheets, sold under the name of ACRYLIT_{GC}® (hereinafter, "the Product"), manufactured to assist natural light transmission through roofs and vertical walls:

1.- In accordance with the ASTM E-903 (1996) standard, Stabilite guarantees that the Product shall not lose more than 8% of the initial values of light transmission over 10 years from the date of invoice. Light transmission for this product is established at 55% on leaving the factory.

2. Glasteel./ Stabilite America, Inc. warrants that there will be minimal fiberbloom as compared to baseline sample testing.

3. Glasteel/Stabilite America, Inc. warrants that there will be a Delta E (Rate of color change) on the yellow index, no greater than 5.5 as measured against the Xenon Arc laboratory testing

4.-Any product under this guarantee which fails to provide the amount of light transmission specified in the above section, or changes color beyond the 5.5 shall be replaced by Glasteel/ Stabilite America, Inc. on behalf of the purchaser, or the latter shall be refunded the amount invoiced on the date of purchase, less 0.8% per month from that date up to a maximum of 120 Months

5.-Point (2) notwithstanding, if the Product is verified to have a loss of light of over 8% during the aforementioned 10-year period, Glasteel/ Stabilite America, Inc., at its sole judgment and discretion, reserves the right to choose between replacing the affected sheet or reimbursing its value (in accordance with point (2) of this guarantee document).

6.-Any claim against a fault in the Product must be made in writing. Glasteel/ Stabilite America, Inc. will not accept any claim that is not accompanied by this guarantee document and the original invoice issued on purchasing the Product. Glasteel/ Stabilite America, Inc reserves the right to inspect those products that are subject to a claim in order to submit them to as many tests as it deems necessary or suitable for corroborating the fault.

7.- This guarantee does not include those faults which the Product may incur as a result of its transport, handling and storage. Damages or faults caused by the following are also expressly excluded from this guarantee:

Breakages or dents of any type, nature, class or size

Abrasion, Exposure to corrosive, toxic, inflammable or dangerous materials

Damage caused by abnormal environmental conditions, such as fires, falling objects, or natural disasters or Acts of vandalism
